Core Competencies

A. Engineering Services

- **FAA Regulatory Compliance**
 - Read and interpret Federal Aviation Regulations, Advisory Circulars, and other guidance material to determine and explain what an Airline Operator must do to be in compliance with each regulation.
 - Write new policy or edit existing policy for operators to comply with new or existing regulations.
 - Assist Operators in obtaining Operation Specifications for ETOPS, RVSM, CAT II/III, Aging Aircraft, and other operations.
- **Develop Custom Aircraft Technical Publications**
